budget process. Budget committees set spending limits for the House and Senate committees and for Appropriations subcommittees, which then approve individual appropriations bills to allocate funding to various federal programs.

Several government agencies provide budget data and analysis. These include the Government Accountability Office (GAO), Congressional Budget Office, the Office of Management and Budget (OMB) and the U.S. Treasury Department. These agencies have reported that the federal government is facing a series of important financing challenges.

True National Debt Exceeds \$123 Trillion, or Nearly \$800,000 per Taxpayer:

America's national debt now exceeds \$123 trillion, according to a new report, or more than four times the official figure of \$28 trillion, as calculated by the U.S. Treasury Department at the end of March. Federal spending related to the CCP virus pandemic and economic lockdown added nearly \$10 trillion to the total in 2020, according to the latest edition of the "Financial State of the Union 2021" report, compiled and published annually by Chicago-based nonprofit Truth in Accounting (TIA).

But spending amid the pandemic represents only a small portion of the total difference between the official

government figure and TIA's calculation.

"Our measure of the government's financial condition includes reported federal assets and liabilities, as well as promised, but not funded, Social Security and Medicare benefits," the report stated. "Elected and non-elected officials have made repeated financial decisions that have left the federal government with a debt burden of \$123.11 trillion, including unfunded Social Security and Medicare promises."

The TIA report includes in its total debt calculation \$55.12 trillion in unfunded Medicare benefits and \$41.20 trillion in unfunded Social Security benefits. Treasury officials don't include unfunded benefits because they claim recipients have no right to future payments, only to those under current entitlement laws. The total debt, according to the report, "equates to a \$796,000 burden for every federal taxpayer. Because the federal government would need such a vast amount of money from taxpayers to cover this debt, it received an 'F' grade for its financial condition."

Unlike many state governments, the federal government doesn't maintain a cash reserve to deal with spending necessitated by unexpected crises such as a virus pandemic. "The coronavirus

pandemic and related stimulus packages have caused some of the deterioration because the government had to borrow money to weather the pandemic. If the federal government was properly prepared for a crisis with a true rainy-day fund, it would not have had to borrow money,” TIA stated.

Defense and veterans’ benefits accounted for the largest share of federal spending in 2020 at 23 percent, followed by health and human services with 19 percent, Social Security with 16 percent, interest on the debt at 5 percent, and 2 percent on education. Fully a third (35 percent) of the spending went to what TIA described as “Other.”

## Responses

Spokesmen for Sen. Bernie Sanders (I-Vt.) and Sen. Lindsey Graham (R-S.C.), respectively the chairman and ranking minority member of the Senate Budget Committee, didn’t respond to The Epoch Times request for comment.

Similarly, a spokesman for House Budget Committee Chairman Rep. John Yarmuth (D-Ky.), didn’t respond.

The annual budget deficit is the difference between actual cash collections and budgeted spending (a partial measure of total spending) during a given fiscal year, which runs from October 1 to September 30. Since 1970, the U.S. federal government has run deficits for all but four years (1998–2001) contributing to a total debt of \$16.1 trillion as of September 2012.

## Public Debt

The United States public debt is



the money borrowed by the federal government of the United States through the issuing of securities by the Treasury and other federal government agencies. US public debt consists of two components: Debt held by the public includes Treasury securities held by investors outside the federal government, including that held by individuals, corporations, the Federal Reserve System and foreign, state and local governments. Individuals, corporations, the Federal Reserve System and foreign, state and local governments.

Debt held by government accounts or intragovernmental debt includes non-marketable Treasury securities held in



accounts administered by the federal government that are owed to program beneficiaries, such as the Social Security Trust Fund. Debt held by government accounts represents the cumulative surpluses, including interest earnings, of these accounts that have been invested in Treasury securities. Rep. Jason Smith (R-Mo.), the budget panel's ranking minority member, referred to a March 31 statement in which Smith criticized news spending proposals from President Joe Biden and congressional Democrats.

Biden's \$2T spending plan, billed as

infrastructure bill, spends less than half on infrastructure.

Less than 6% of the proposal goes to roads and bridges, critics say President Biden's \$2 trillion spending plan, which is being promoted largely as a bill to address infrastructure, directs well under half of its total money to things traditionally defined as infrastructure, according to a Fox News analysis.

The analysis, based on the 25-page summary of the president's proposal for the "American Jobs Plan," indicates less than \$750 billion of the spending fits even a broad definition of infrastructure.

The White House is casting a very wide net about what constitutes infrastructure — for example, the American Jobs Plan references "care infrastructure" when talking about \$25 billion to upgrade child care facilities and a \$400 billion expenditure on care for the elderly and disabled. That's quite different from repairing potholes and rebuilding bridges. Senate Republicans, meanwhile, in emphasizing that Biden's plan largely does not address infrastructure, are often using a very restrictive definition of the word. (twisting the truth\_)

## REPUBLICAN SENATORS LINE UP AGAINST BIDEN'S MASSIVE \$2T SPENDING BILL: 'FAR CRY' FROM INFRASTRUCTURE

Indeed, the White House summary of the American Jobs Plan says it will spend "\$115 billion to modernize the bridges, highways, roads, and main streets that are in most critical need of repair" out of more than \$2 trillion in the plan. That is slightly under 6%.

"The first thing to know is there is no hard definition of infrastructure. Economists have no hard definition of infrastructure," Edwards said in an interview with Fox News.

Fox News' analysis of the Biden plan, as outlined in its 25-page fact sheet, broadly counted investments going toward physical repair or building of facilities and systems used by the general public that help the economy. This includes, for example, replacing lead pipes, expanding broadband access and modernizing public schools, in addition to money going to things traditionally associated

with the word infrastructure like roads, bridges and ports. *(I E....THE "GREEN NEW DEAL"....COMMUNISM ENACTED! TAX FUNDED! ARE YOU OFFENDEE?)*

Other items that counted to reach a total of just under \$750 billion included \$50 billion to preserve infrastructure resilience, \$80 billion for Amtrak and \$20 billion for road safety. *(What is Road Safety?)*

Elements of the Biden plan Fox News excluded from this analysis included \$174 billion being spent on electric vehicles; \$400 billion on home-based care for the elderly and disabled; \$25 billion on child care facilities; and \$50 billion on "research infrastructure" at the National Science Foundation. *(FAUCI PAY BACK FOR PANDEMIC?)*

Fox News also excluded \$213 billion in Biden's plan that's directed at home sustainability and public housing; at least \$35 billion aimed at R&D related to climate change; (Money laundering to Biden big donors?)

\$50 billion to create a new office at the Department of Commerce to "dedicated to monitoring domestic industrial capacity and funding investments to support production of critical goods; \$30 billion to prepare for future pandemics; \$45 billion for the federal government to buy clean energy goods; \$14 billion "to bring together industry, academia, and government to advance technologies and capabilities critical to future competitiveness;" and several other provisions. One part of Biden's plan that does not cost any money is the PRO Act, which would essentially override right-to-

work laws in states across the country, allowing unions to extract dues from workers who do not want to be members. Biden's American Jobs Plan, at this point, is simply a 25-page document of suggestions. Legislators have not even begun drafting it. That means dollar totals and specific allocations co

Cato's Edwards, meanwhile, says his biggest gripe with the Biden plan is that the money being spent, no matter how it is defined, is largely going into the pockets of big corporations. *"It's hugely ironic because the leading Democrats have bashed corporate welfare and corporate subsidies for years, and they always claim that Republicans do corporate subsidies,"* Edwards told Fox News. *"But in fact, Biden would subsidize corporations hundreds and hundreds of billions of dollars with this plan."* "Manufacturing, \$300 billion. Electric vehicles, \$170 billion. Broadband, \$100 billion. Electric power grid, \$100 billion. This is completely unneeded and it's also very dangerous because we don't want the federal government manipulating what broadband companies do, what electric power companies do," Edwards said.

He added: "One of the interesting political things in coming weeks and months will be will the Democrat left, like Sanders and Warren, kind of come to the realization that, 'Hey, this is massive corporate subsidies here, which we're supposed to be against.'"

**LAWMAKERS.** Edwards also said that the corporate tax hikes used to fuel the \$2 trillion-plus spending plan would be counterproductive to its goals, hurting the massive private companies like "AT&T and Verizon and other companies that do broadband and invest-- you know infrastructure investment." "Biden would be taking with one hand in taxes what he's giving on the other end, subsidies, which makes no sense," Edwards said. Biden and the White House, of course, would dispute Edwards' points.

A sexual harassment allegation is something that can seriously damage one's career, especially if that individual is serving in an office of public trust, such as the governor of a state. Gov. Andrew Cuomo (D-NY) has been embattled in scandal over alleged sexual misconduct with multiple women on the campaign



trail and in his office. Top New York Democrats are calling for his resignation and impeachment. But in his case, there is no paper trail tying mountains of cash to hush-money payments to accusers to keep them quiet. But that story is much different in New Mexico.

Democrat ex-governor Bill Richardson allegedly made \$250,000 in hush-money payments from his campaign to a woman who had threatened to file a sexual harassment suit against him from a bank account in Mexico, according to the New York Times. Richardson was also accused of being involved with pedophilic sexual predator Jeffrey Epstein, who trafficked underage girls. According to reports, "a woman claims Jeffrey Epstein directed her to have sex with powerful men, including former New Mexico Governor Bill Richardson."

It is unclear if extremely large hush-

money payments of taxpayer funds involved sexual harassment accusations during the Republican Susana Martinez Administration, which amounted to over \$1.7 million. But they sure happened. According to KRQE, "Sources say the Risk Management Division paid a group of disgruntled public employees huge sums of money in order to keep alleged compromising information about then Governor Susana Martinez under wraps."

Now, Democrat Gov. Michelle Lujan Grisham has admitted to sending \$62,500 in hush money payments from her campaign to her former aide, James Hallinan, after he accused her of pouring water over his crotch and then groping him in 2018. As CNN reports, Lujan Grisham claimed just last month to believe Cuomo's accusers and all sexual harassment accusers in an interview with the Washington Post. She said, "We need to take seriously all these allegations and I'm frankly in that group of elected leaders that you believe the individual. You give real credit and credibility there. If you don't, we're re-victimizing brave men and women who come forward." It may seem to some that Lujan Grisham is just following in the footsteps of her corrupt predecessors who made large payments to their alleged accusers, some with taxpayer funds and some with campaign cash to keep the scandals out of the press. But this is by no means the first time Lujan Grisham has been accused of similar behavior. According to a video made by a man named Eddie Dehart, Lujan Grisham allegedly grabbed his genitals during a birthday party in 2005.



According to Dehart, attendees of the party were playing pool when Lujan Grisham was alleged to have groped him in front of his then-girlfriend, saying, “you have a man here” after touching his genitals through his clothes.

With other politicians who have been embattled with sexual harassment scandals leaving office in disgrace, such as former Rep. John Conyers (D-MI) who paid off one victim \$27,000 to keep quiet, or current Rep. Tom Reed (R-NY) who has announced he will not seek re-election, a sexual harassment scandal can destroy a politician’s career if the accusations have merit. Despite Lujan Grisham’s claims that the groping never happened, payments of tens of thousands of dollars to an accuser are not necessarily something that makes one look innocent, especially as the 2022 elections are right around the corner and Lujan Grisham must battle for her political life. Lujan Grisham was previously considered for a cabinet position in the Joe Biden administration but did not receive a post, which may have had something to do with these hush payments to Hallinan. Gov. Andrew Cuomo was also considered but also did not receive a post in the administration. Many have concluded that the alleged behavior of people like Cuomo and others puts them in the “sexual predator” category. A sexual predator “is a person seen as obtaining or trying to obtain sexual contact with another person in a metaphorically ‘predatory’ or abusive manner.” Allegedly groping multiple victims’ crotches on possibly multiple occasions throughout the years may

certainly be a sign that even more nefarious sexual activity may have happened in the past by Lujan Grisham. Does such activity make Gov. Michelle Lujan Grisham a sexual predator? It depends on what further details may come out regarding other possible instances of sexual deviance.
