## **HAS AG BARR COMMITTED TREASON BY COVERING UP THE RIGGING OF ELECTIONS?**

Definition of Treason. Treason against the United States, shall consist only in levying War against them, or in adhering to their Enemies, giving them Aid and Comfort. No Person shall be convicted of Treason unless on the Testimony of two Witnesses to the same overt Act, or on Confession in open Court.

Treason Clause...US CONSTITUTION

U.S. Department of Justice; Criminal Division, Appellate Section by Deborah Pearlstein Professor of Law and Co-Director of the Floersheimer Center for Constitutional Democracy at Yeshiva Univeristy Cardozo Law School. Treason is a unique offense in our constitutional order—the only crime expressly defined by the Constitution, and applying only to Americans who have betrayed the allegiance they are presumed to owe the United States.

While the Constitution's Framers shared the centuries-old view that all citizens owed a duty of loyalty to their home nation, they included the Treason Clause not so much to underscore the seriousness of such a betrayal, but to guard against the historic use of treason prosecutions by repressive governments to silence otherwise legitimate political opposition.

Debate surrounding the Clause at the Constitutional Convention thus focused on ways to narrowly define the offense, and to protect against false or flimsy prosecutions.

## Disputing Trump, Barr says no widespread election fraud

WASHINGTON (AP) — Disputing President Donald Trump’s persistent, baseless claims, Attorney General William Barr declared Tuesday the U.S. Justice Department has uncovered

no evidence of widespread voter fraud that could change the outcome of the 2020 election.

Barr’s comments, in an interview with the The Associated Press, contradict the concerted effort by Trump, his boss, to subvert the results of last month’s voting and block President-elect Joe Biden from taking his place in the White House.

Barr told the AP that U.S. attorneys and FBI agents have been working to follow up specific complaints and information they’ve received, but “to date, we have not seen fraud on a scale that could have effected a different outcome in the election.” The comments, which drew immediate criticism from Trump attorneys, were especially notable coming from Barr, who has been one of the president’s most ardent allies.

Trump has long railed against the investigation into whether his 2016 campaign was coordinating with Russia, but he and Republican allies had hoped the results would be delivered before the 2020 election and would help sway voters. So far, there has been only one criminal case, a guilty plea from a former FBI lawyer to a single false statement charge.

An investigation into SEC filings has revealed that the firm which owns Dominion Voting Systems received \$400 million dollars from a Swiss bank with close links to the Chinese government less than a month before the election.

The investigation, conducted by Austin Security and Investigation Solutions, centers on Staple Street Capital, which acquired Dominion Voting Systems in 2018.



Dominion Voting Systems operates voting machines in 28 states and has been accused by President Trump and his supporters of being involved in deleting millions of votes for Trump in addition to switching votes to Biden on election night.

“On Oct 8, 2020, Staple Street Capital filed SEC Form D offerings and sales amount of \$400,000,000 with the Sales Compensation Recipient identified as UBS Securities,” states the investigation, which also notes that another payment of \$200,000,000 was received in December 2014.

UBS Securities is a swiss investment bank which owns 24.99% of UBS Securities Co LTD, a Chinese Investment Bank. The remaining 75% of UBS Securities CO LTD is owned by the Chinese government,” states the report.

Attorney Sidney Powell told Fox news host Sean Hannity Monday night that witnesses to election fraud have been threatened, and in one case, beaten up and is in hospital.

*whistleblowers,”* Powell said.

Powell filed lawsuits both in Michigan and Georgia last week, alleging massive election fraud and irregularities. When asked why some people witnessing an internet connection in real-time couldn’t speak up publicly, Powell responded that *“some are within the government, some are possibly in different roles that require confidentiality, and they’re not in a position where they can come forward without certain protections in place.”*

Powell called on the government to provide such protections to *“get to the truth of all that matters.”* . . .

*“We got evidence of corruption all across the country and countless districts,”* she said. Powell, a former federal prosecutor, had been the lead attorney for General Michael Flynn who recently received a pardon by President Donald Trump. During the interview when Hannity suggested that Trump should pardon himself and his whole family to prevent a future *“witch hunt.”* Powell said that she did not know about Trump’s *“authority to pardon himself.”*

Powell went on to say that such a pardon should not be necessary because *“the president is going to get another four years in office to finish the job he started because the election fraud we’re uncovering is massive.”*(Excerpt from *The Epoch Times*. Article by Li Hai.)

3. An order requiring Governor Kemp to transmit certified election results that state that President Donald Trump is the winner of the election; 4. An order that no votes received or tabulated by machines that were not certified as required by federal and state law be counted; 5. A declaratory judgment declaring that Georgia Secretary of State Rule 183-1-14-0.9-.15 violates O.C.G.A. § 21-2-386(a)(2) and the Electors and Elections Clause, U.S. Const. Art. I, § 4;

A declaratory judgment that Georgia's failed system of signature verification violates the Electors and Elections Clause by working a de facto abolition of the signature verification requirement; 7. Wednesday, December 2, by 3:00 p.m., EST. Any reply brief will be due Thursday, December 3, by 3:00 p.m., EST. The Court will hold an in-person hearing on Plaintiffs' motion on Friday, December 4, at 10:00 a.m., EST, in Courtroom 2106, United States Courthouse, 75 Ted Turner Drive, Atlanta, Georgia, 30303. In addition, Plaintiffs contend that Union County officials have advised that they are going to wipe or reset the voting machines of all data and bring the count back to zero on Monday, November 30.

On this basis, Plaintiffs seek a temporary restraining order to impound and preserve the voting machines in the State of Georgia, and to prevent any wiping of data. However, Plaintiffs' request fails because the voting equipment that they seek to impound is in the possession of county election officials. Any injunction the Court issues would extend only to Defendants and those within their control, and Plaintiffs have not demonstrated that county election officials are within Defendants' control.

Defendants cannot serve as a proxy for local election officials against whom the relief should be sought. *Jacobson v. Fla. Sec'y of State*, 974 F.3d 1236, 1256-58 (11th Cir. 2020). Therefore, to the extent Plaintiffs seek emergency relief to impound and preserve the voting machines, that request is denied. Defendants are ordered to promptly produce to Plaintiffs a copy of the contract between the State and Dominion.
